



eFacts ACADEMIC FACILITY LICENSE AND NONDISCLOSURE AGREEMENT

This License and Nondisclosure Agreement is between Facts & Comparisons, a division of Wolters Kluwer Health, Inc. and the party identified below as the "Licensee."

OVERVIEW: Licensee desires to obtain the use and Facts & Comparisons grants to Licensee a nontransferable and nonexclusive use of eFacts, a line of browser-based products, ("Licensed Products"), in accordance with the terms and conditions of this Agreement.

Licensee shall pay Facts & Comparisons for the use of the Licensed Products an annual license fee of \$_____.

TERMS AND RENEWAL: This Agreement is effective as of the date first indicated below and shall be for an initial term of 3 (three) years. This Agreement shall be automatically renewed for successive terms of three years each, at the then current annual fees, unless either party notifies the other no later than thirty days prior to the expiration date of the current term that the Agreement shall not be renewed. Use of any Licensed Products after expiration is specifically prohibited.

USE OF LICENSED PRODUCTS BY LICENSEE: Licensee shall use the License Products solely within its primary campus location on desktop or laptop computers that access the Core Content resident on Facts & Comparisons' web server supporting the www.factsandcomparisons.com web site by means of either a secure username and password or recognition of an IP address or range of IP addresses associated with one or more web or proxy servers that provide access to the internet for such computers. Use of the Licensed Products is limited to the Licensee's School of Pharmacy and main campus locations.
