

LICENSE AGREEMENT  
For University of California at San Diego  
To Use Interviews, Metadata, and the Visual History Archive

This License Agreement ("Agreement") is entered into on or about March 26<sup>th</sup>, 2007, between the University of Southern California, on behalf of its Shoah Foundation Institute for Visual History and Education ("USC Shoah Foundation Institute"), whose mailing address is [REDACTED], and The Regents of the University of California, on behalf of the University of California San Diego Libraries ("Licensee"), whose mailing address is [REDACTED].

DEFINITIONS:

"Interview(s)": USC Shoah Foundation Institute videotaped interviews.

"Metadata": Indexing and cataloguing data associated with Shoah Foundation Institute's videotaped interviews.

"Segment(s)": Segment(s) from the Interview(s) or Metadata.

"Visual History Archive" or "VHA": A web-based software tool that provides access to the Interview(s) and Metadata or any Segment(s) thereof.

"University Computer Network": Any computer network, wherever located, run, owned or used by Licensee.

"Authorized Users": University students, faculty and staff, visiting professors, and other University-affiliated or otherwise authorized individuals, whose identity is known to Licensee and who are authorized by Licensee to have access to the University Computer Network.

Term of Agreement: Specified in Section 5.a. and renewal upon the parties' mutual written consent.

This Agreement specifies the terms and conditions for use of USC Shoah Foundation Institute Interviews, Segments, Metadata, and the Visual History Archive to Licensee.

The USC Shoah Foundation Institute and Licensee agree as follows:

**1. Scope of Rights Granted**

- a) The USC Shoah Foundation Institute grants Licensee a non-exclusive, revocable, non-transferable license to use and permit public viewing of Interviews and Metadata through the Visual History Archive on computers connected to the University Computer Network for the Term of this Agreement for the fee set forth in section 3.
- b) Licensee and Authorized Users may download, copy, edit, and use the Interview(s), Metadata, or Segment(s) thereof accessed through the Visual History Archive subject to the provisions of this Agreement. Licensee and Authorized Users shall insert all whole or partial copies of the Interview(s) that Licensee makes into DVD or VHS hard boxes with a full window ("Box"), and shall include in the Box the USC Shoah Foundation Institute approved exemplar Interview label ("Label"), to be provided upon request. Licensee shall also affix a label directly on any DVD discs or VHS tapes of whole or partial copies of the Interview(s) which states © **USC Shoah Foundation Institute, University of Southern California.**
- c) Licensee and Authorized Users may use the Interviews, or any Segments thereof, for educational projects onsite and offsite. Such projects may include but are not limited to, classroom instruction, research, educational programs, development of teaching tools, faculty research, use in educational exhibits, use at educational or academic conferences, and use in Licensee's internal websites that are only accessible by Authorized Users.
- d) Licensee shall distribute, and shall instruct Authorized Users to distribute, any copies made of Interview(s) or Segment(s) by Licensee or Authorized Users only on-campus, off-campus at University-affiliated locations or educational or academic conferences, or through the University Computer Network to other Authorized Users unless a License is obtained, in advance, from the USC Shoah Foundation Institute for any use or publication of Interview(s) or any Segment(s) thereof off-campus or on computer networks other than the University Computer Network. A one page sheet summarizing the Terms of Use is attached hereto as Exhibit A.

- e) The USC Shoah Foundation Institute grants Licensee a royalty-free, non-exclusive, non-transferable license to download the Metadata on internal computer networks owned and operated exclusively by Licensee, to internally experiment with the Metadata, to determine its potential uses and to use the Metadata for internal research and related purposes.
- f) Licensee may integrate the Metadata with data in Licensee's other databases provided Licensee identifies the USC Shoah Foundation Institute as the copyright owner of such data.
- g) Licensee may not make changes, additions, alterations, or modifications to the Metadata without written permission from the USC Shoah Foundation Institute.
- h) Licensee shall not use the Interview(s) or Segment(s), or the Interviewee(s)' name(s), in any manner on the Internet without prior authorization from the USC Shoah Foundation Institute.
- i) Licensee may not authorize anyone other than Licensee and Authorized Users to use or exploit the Interview(s) or Segment(s) or Metadata.
- j) Licensee shall refer third parties to the USC Shoah Foundation Institute for permission to publish or for a license for any use of materials from the Visual History Archive.
- k) Licensee shall not charge a use fee for access to the Visual History Archive, Interviews or Metadata or any portion or copy thereof, but the Licensee may charge patrons any normal admission fee.
- l) Licensee and Authorized Users may not use Interview(s) or Segment(s) for fundraising without prior written approval by USC Shoah Foundation Institute.
- m) Licensee shall notify the USC Shoah Foundation Institute in the event that it learns of a breach of this Section. Failure to comply with the terms of this Section may subject the Licensee to penalties for copyright infringement, among others.

- n) Licensee shall not permit any institutions to have access to the Interviews, Metadata, and/or Visual History Archive over Internet2 or over other similar private institutional networks without prior written permission from the USC Shoah Foundation Institute. USC Shoah Foundation Institute and Licensee shall determine at a future date the possibility of permitting other institutions access to the Visual History Archive through Licensee.
- o) Licensee has no ownership or proprietary interest in or to the Interviews, Metadata, or Visual History Archive and may not transfer, license, rent, lease, or assign their rights to use the same to anyone, other than as specified in this Agreement or without prior written approval by USC Shoah Foundation Institute.
- p) Licensee understands that the USC Shoah Foundation Institute owns the worldwide copyrights to the Interviews, Metadata, and Visual History Archive. Nothing in this Agreement affects such copyright ownership. The information contained in the Interviews involves privacy interests and is not in the public domain.
- q) Licensor shall use reasonable efforts to keep the Visual History Archive up and online. Should the Visual History Archive become unavailable, Licensor shall use reasonable efforts to bring the Visual History Archive back on-line as soon as practicable.

## 2. Representations or Warranties

- a) The USC Shoah Foundation Institute represents and warrants for the benefit of licensee that it has the right to license the Interviews, Metadata, and Visual History Archive to Licensee under the terms of this Agreement. No other representations or warranties, express or implied, are made by the USC Shoah Foundation Institute with respect to the Interviews. Subject to the terms hereof, they are provided to Licensee on an "AS-IS" basis.
- b) The USC Shoah Foundation Institute makes no representations or warranties with respect to the Interview, except that it has obtained all rights from the Interviewee, interviewers, and videographers to issue this Agreement. The USC Shoah Foundation Institute cannot ensure that its copyrighted Interview is free from defamatory comments or materials owned by third parties. The USC Shoah Foundation Institute does not verify the accuracy of the information in the Interview. The Licensee understands and agrees that the USC Shoah Foundation Institute shall not be responsible or liable for any loss or damage resulting from the uses permitted under this Agreement.

- c) The USC Shoah Foundation Institute and Licensee agree to maintain the confidentiality of any data relating to the usage of the Licensed Materials by Licensee and its Authorized Users. Such data may be used solely for purposes directly related to the Licensed Materials and may only be provided to third parties in aggregate form. Raw usage data, including but not limited to information relating to the identity of specific users and/or uses, shall not be provided to any third party.
- d) Licensee makes no representations or warranties with respect to its University Computer Network or the availability of the Interviews or Metadata on such network.

### 3. Costs and Considerations

- a) The USC Shoah Foundation Institute shall invoice the Licensee for the payment of an annual subscription fee of (US) [REDACTED] to cover costs incurred by USC Shoah Foundation Institute associated with preserving, maintaining, upgrading, and delivering the Interviews, Metadata, and Visual History Archive. USC Shoah Foundation Institute reserves the right to change future estimated yearly subscription costs to reflect actual and reasonable increases in costs. - b) Licensee understands it must have a dedicated server with at least ONE terabyte of storage on Licensee's campus.

### 4. Acknowledgement

- a) The USC Shoah Foundation Institute shall have the right to reasonable use of Licensee's name for the USC Shoah Foundation Institute's publicity activities during the term of this Agreement.
- b) Licensee and Authorized Users shall acknowledge the USC Shoah Foundation Institute as the copyright owner of Interview(s) and Segment(s) in any uses made of Interview(s) or Segment(s).

- c) USC Shoah Foundation Institute and Licensee shall mutually agree on acknowledgment in all materials referring to the USC Shoah Foundation Institute's Visual History Archive, if the USC Shoah Foundation Institute is to be mentioned. This includes: 1) All printed materials (e.g., brochures, catalogues) and signage about the Testimonies, Metadata and/or Visual History Archive, including information that appears on the Internet or on Licensee's Web site; 2) All press and promotional materials about the Visual History Archive, Testimonies and/or Metadata; 3) All educational materials made from the Visual History Archive, Testimonies and/or Metadata.
- d) Licensee shall provide the USC Shoah Foundation Institute with a copy of all materials produced for the public, mentioning the USC Shoah Foundation Institute and/or the Interviews, Metadata, or Visual History Archive.
- e) With regard to Metadata integrated into Licensee's existing systems, Licensee shall identify the USC Shoah Foundation Institute as the copyright owner of such data.

## 5. Term and Termination

- a) This Agreement shall commence on April 9, 2007 and shall continue in full force until April 8, 2008. The Parties shall have the option to renew the Agreement at the end of the term in writing based on mutually agreed terms and conditions.
- b) Upon any material breach or default by either party, the non-breaching party shall have the right to terminate this Agreement and the rights and license granted hereunder by thirty (30) days written notice to the breaching party. Such termination shall become effective unless the breaching party has cured any such breach or default prior to the expiration of the thirty (30) day period. In the event of a termination for cause, the breaching party shall pay the costs of deleting or removing any digital copies of Interviews from the University Computer Network and returning any physical copies of Interviews to the USC Shoah Foundation Institute.

- c) This Agreement constitutes the entire agreement of the parties and supersedes all prior and contemporaneous agreements, communications, understandings, and agreements relating to the subject matter hereof, whether oral or written, including any agreements associated with the order or trial request process.
- d) Should there be a conflict between this agreement and any other vendor-generated, web accessible terms and conditions, whether now known or hereinafter generated, then this Agreement controls.
- e) This Agreement may only be modified in a writing signed by both parties.

## 6. Limitation of Damages

NOTWITHSTANDING ANYTHING TO THE CONTRARY CONTAINED HEREIN, TO THE MAXIMUM EXTENT PERMITTED BY LAW, IN NO EVENT WILL EITHER PARTY BE RESPONSIBLE FOR ANY INCIDENTAL, CONSEQUENTIAL, INDIRECT, SPECIAL, PUNITIVE, OR EXEMPLARY DAMAGES OR ANY KIND, INCLUDING DAMAGES FOR LOST GOODWILL, LOST PROFITS, LOST BUSINESS OR OTHER INDIRECT ECONOMIC DAMAGES, WHETHER SUCH CLAIM IS BASED ON CONTRACT, NEGLIGENCE, TORT (INCLUDING STRICT LIABILITY) OR OTHER LEGAL THEORY, AS A RESULT OF A BREACH OF ANY WARRANTY OR ANY OTHER TERM OF THIS AGREEMENT, AND REGARDLESS OF WHETHER A PARTY WAS ADVISED OR HAD REASON TO KNOW OF THE POSSIBILITY OF SUCH DAMAGES IN ADVANCE.

## 7. Indemnity

The Licensee shall defend, indemnify and hold the USC Shoah Foundation Institute harmless from and against any and all damages, liability, loss, and claims, including reasonable attorney's fees, resulting from any breach of Licensee's obligations under this Agreement.

## 8. Mandatory Arbitration

The USC Shoah Foundation Institute retains the right to sue as a first party for breach of its copyrights, license agreements, and any other rights on, or in, the Interviews. Any dispute or claim between the USC Shoah Foundation Institute and Licensee in connection with this Agreement shall be settled by binding arbitration in accordance with the procedures of the American Arbitration Association ("AAA"). The arbitrator shall have the authority to grant any relief allowed by law, including, but not limited to, provisional, equitable and/or declaratory relief. The parties shall each pay one-half of the arbitration fees. The parties shall each pay their own attorneys' fees. The parties may seek and obtain injunctive relief in any court having jurisdiction for unauthorized use of the Interviews and may then proceed with arbitration under this Agreement.

## 9. Notices

Any notices required under this Agreement shall be sent to the USC Shoah Foundation Institute and the Licensee via fax or first class mail, and shall be effective upon receipt at the following fax numbers or addresses:


## 10. Miscellaneous Provisions

- a) Licensee understands that the USC Shoah Foundation Institute cannot offer this type of Agreement to every organization, and agrees that it will not distribute copies of this Agreement to Third Parties except as required for performance hereunder or as required by law. Licensee shall only publicly disclose terms from this Agreement that are necessary for Licensee to comply with its duties and obligations hereunder or as required by law.
- b) Nothing contained herein shall limit the Shoah Foundation Institute's right to make similar agreements with any other person, organization or entity, for any purpose whatsoever.
- c) Nothing contained in this Agreement is intended or shall be construed to create any legal partnership, joint venture or agency relationship between the USC Shoah Foundation Institute and the Licensee.
- d) Except as expressly provided herein, neither party may use the name, trade name, trademark, domain name, or other designation of the other party in connection with any products, promotion, marketing, press release or advertising without the prior written consent of the other party. Licensee is prohibited from using the name Steven Spielberg in any way related to this Agreement or Licensee's use of the Interviews.
- e) The foregoing provisions shall be enforced to the fullest extent of the law in each jurisdiction. If any of the foregoing provisions is adjudicated to be invalid or unenforceable, the remainder of the Agreement shall remain in full force and effect. This Agreement contains the entire understanding between the parties relating to the subject matter hereof. This Agreement can be modified only by a written document signed by both parties. No waiver of any term or condition of this Agreement shall be construed as a waiver of any other term or condition.
- f) This Agreement shall be binding upon and inure to the benefit of the parties' successors, assigns, Licensees and their respective directors, officers, employees, representatives and agents. The USC Shoah Foundation Institute may freely assign this Agreement.
- g) Sections 6, 7, and 8 survive the termination of this Agreement.

- h) Licensee is responsible for the payment of all applicable taxes, or other charges directly applicable to the stipulations outlined in this Agreement.
- i) This Agreement may be signed in one or more counterparts, each of which shall be deemed to be an original, and all of such, when taken together, shall be deemed to constitute one and the same document.

EXHIBIT A  
TERMS OF USE

USC SHOAH FOUNDATION INSTITUTE FOR VISUAL HISTORY AND EDUCATION

The USC Shoah Foundation Institute owns the intellectual property rights, including copyrights, to its Interviews, Metadata, and the Visual History Archive. All rights are reserved by the USC Shoah Foundation Institute. The Metadata is the Institute's indexing and cataloguing data. The Visual History Archive is a software tool that provides access to the Interviews and Metadata.

**Rights Granted to Use Testimonies, Metadata, and Visual History Archive**

The USC Shoah Foundation Institute grants you permission to access and view Interviews and Metadata and any segments thereof (collectively referred to as "Segments") through the Visual History Archive on computers connected to the University Computer Network. For the purpose of this Agreement, University Computer Network shall mean any network, wherever located, run, owned or used by University.

The USC Shoah Foundation Institute also grants you a non-exclusive, non-transferable license to download, copy, exhibit and use Interviews or Segments accessed through the Visual History Archive subject to the provisions below:

Interviews or Segments may be used for onsite and offsite educational projects, including, but not limited to, classroom instruction, educational programs, research, development of teaching tools, faculty research, use in educational exhibits, use at educational or academic conferences, and use in connection with the University Computer Network.

A copyright notice must appear on any physical media (e.g. videotape, DVD, etc.) and in any educational projects made from Testimonies or Segments. The copyright notice shall state: *Interviewee Testimony Segments © USC Shoah Foundation Institute, University of Southern California*. Any copies made of Testimonies or Segments must be distributed only on-campus, off-campus at University-affiliated locations, off-campus at educational or academic conferences, or through the University Computer Network unless a separate License is obtained from the USC Shoah Foundation Institute.

The USC Shoah Foundation Institute's recommended citation standard for scholarly works is: *Interviewee's first name, first initial of interviewee's surname, date of interview, followed by "Interview by USC Shoah Foundation Institute for Visual History and Education, University of Southern California," location of interview, tape number(s), and time code, if applicable.*

**When a License is Required**

A separate License must be obtained, in advance, from the USC Shoah Foundation Institute for any use or publication of Interviews or Segments at non-affiliated off-campus sites, except at off-site educational or academic conferences, or on computer networks other than the University Computer Network. The Institute will need to know how you would like to use the Interviews or Segments and the names and interview codes of the Interviewees.

**Additional Terms:**

Interviews or Segments may not be sold, transferred or licensed except by the USC Shoah Foundation Institute. No one may give or loan any downloaded copies of Interviews or Segments to persons not connected to the University Computer Network or qualified as a University Affiliate, or permit such persons to copy or download Segments, unless a separate License is obtained from the USC Shoah Foundation Institute as specified above. In the event of a breach of the *Terms of Use*, the USC Shoah Foundation Institute must be promptly notified. Failure to comply with the *Terms of Use* may subject violators to penalties for copyright infringement.
