Description: The American Tunaboat Association (ATA) was established in San Diego in 1951 as a non-profit cooperative association to assist tunaboat owners and crews. The collection includes material documenting the San Diego tuna industry from 1937-1994, and material documenting the work of the ATA from 1951-1982. Includes correspondence, financial records, trip statements and records, ships logs, reports relating to international law and the tuna industry, material documenting the Inter-American Tuna Commission, correspondence, reports and notes relating to the Atlantic Tuna Commission and tunaboat seizures, newspaper clippings and photographs. Includes material on tuna/porpoise rescue, reports, data, statistics and court cases. Included are the Marine Mammal Protection Act files, lawsuits, regulations, legal documents, negotiations, legislation and enforcement. Also, material documenting Tuna Fishermen's trust funds, observer handbooks and manuals and other papers. The collection also includes native island reports and Law of the Sea statistics. It also includes material documenting the lives, working conditions and wages of fishermen and the organization of fishermen's unions. The collection also includes oversize boxes containing scrapbooks.
