Friends,

This note is going to all those who have offered to serve as boycott coordinators in their local area. You will find enclosed the following: (1) The Movement Boycott Supplement which can be ordered for \$2.50 per 100 from The Movement; 1316 Masonic St.; San Francisco, California; (2) a letter that is being sent to all possibly interested persons and organizations asking them to participate in the boycott: (3) a list of all boycott centers and others who are involved in the boycott or in farm labor in California.

So that we can know what is being done around the country, we would very much appreciate your sending us clippings from the press about your activities, copies of leaflets that you put out, etc., etc.

If you have ideas that you think might be helpful to the boycott, send them along so that they can be included in subsequent boycott memos.

We would like to stress the following points: (1) it is our desire to see the farm workers of Delano projected as much as possible; thus we ask boycott groups to indicate in their press releases and otherwise that they are responding to the call from the National Farm Workers Association for a boycott of Schenley Liquors and Delano grapes; (2) we hope that every effort will be made to reach groups that may not be typically associated with picket lines: church social action committees and social concern committees, community groups, Spanish-speaking organizations; (3) locals of labor unions—both AFL-CIO and independent should respond very well to the boycott call.

FUNDS FOR THE BOYCOTT ARE DESPERATELY NEEDED. IF YOU CAN RAISE FUNDS, SEND THEM TO "NFWA BOYCOTT" AT EITHER OF THE

ABOVE ADDRESSES. You might have collection cans with you at stores, churches, union halls, etc.

Section on Churches (Protestants, Catholics, Jews): general framework to give credit to lay activists and social action ministers, priests, to note participation of some official bodies, to ask where the major ecclesiastical bodies are—Board of Rabbis, Catholic Dioceses, Councils of Churches, denominational bodies.

Section on Unions (ILWU, AFL-CIO, Teamsters, Independents): to quote Cesar on ILWU, to note rank and file and local support around the country, to ask where big labor is.

Section on Civil Rights groups: to note CORE, SNCC, MFDP, local community group participation, NALC (N.Y.); to ask where the NAACP has been and call upon Negro political leaders to demand of Governor Brown that he publicly urge negotiations between the growers and the two unions.

Section on the students: talks about student groups across the country manning the picket lines; urges students to continue their support of the boycott.

Section on Democrats: where is the party of the people? Note failure of Governor Brown to speak out. Dig up stuff on what Wirtz should do regarding El Paso/Juarez situation. Check out CDC and reprint section of Demo County Central Committee of Santa Clara. Call upon Democrats across the State and Nation to demand of County Committees a resolution urging support of the Schenley Liquor/Delano grape boycott.

Reprint brand names/note revisions, additions, etc.

Letter to boycott supporters from Cesar Chavez, thanking them for their work, stressing the importance of continuing boycott activity.

Notes on the H.L. Mitchell discussion regarding the abortive Schenley boycott of 1950. Additional information from Anne Draper and <u>Hank Anderson</u>.

State-wide round-up of activities: Jerry Sampson to put together pieces of news notes from around the State; names and addresses of people around the State who are working on the boycott as boycott contacts.

Tactics: notes on different tactics. "Angry consumers across the country have taken the situation in their own hands. A group in New York, including a number of civil rights activists, went from liquor store to liquor store in Harlem asking store owners to take Schenley products off their shelves. Almost all the owners were cooperative. One who wasn't found himself with 30 or so would-be-consumers milling around in his store. They didn't buy anything, but the effect of the crowd inside kept other consumers from coming in."

Other tactics: hand-outs at factory gates, quickie informational picket lines in front of stores, resolutions from a variety of community groups supporting the boycott, resolutions from city councils urging stores in the city not to carry products from struck companies.
