I am all for the idea of the vigils at homes of directors of DiGiorgio and Schenley. Can you get the addresses of DiGiorgio board? As far as I am concerned, go ahead on this action, and call on me for whatever help I can give.

Rabbi Steve Forstein called and informs me that the reformed rabbis of West Coast just now voted to make money raising appeal for Delano and also to support the boycott. We should take advantage of this. He will be here tomorrow and I will pump him for names of rabbis who will act to put pressure on Schenley. Any of those directors of Schenleys happen to be Jewish? How about calling someone to research DiGiorgio and Schenley and come up with a biography on each director.

I will be in the Bay Area next Tuesday to face a Presbyterian firing squad. How about meeting you at your office at about 12:00? I have to be at 1st Presby Church at 3:00.

Ron Olson is pressuring Natl. Presby. Church to threaten to withdraw their capital invested in A&P if that chain fails to uphold the boycott. Good angle. Any way to help him out?

Al Green pulled a real fast one here. He referred to NFWA as a service org. and civil rights movement, not a union, administered by ministers. I guess I will enclose the clipping. Perhaps you can use it in some way.

In late April, after pruning I think Cesar should take national speaking tour. I don't know much about what such tours do to an org. so before I make the suggestion to Cesar I would like to get your reaction.

Hope to see you next Tuesday. Bob Solodow, trapped in NYC, phones that East Coast looks good on boycott and ILA shutdown on grapes. No response from Canada ILWU on boycott. Find contacts up there.
