On Tuesday, January 27th, the California Senate voted 20 to 15 in favor of the appropriation, but this was short of the 2/3 vote needed. At this time, it is not exactly clear what all of this is going to mean to the future of the ARRD and the law itself. We do know that as of now, no more cleations can be held, unfair labor practice hearings on hundreds of elections have been halted, election victories cannot be certified and negotiations cannot begin; the growers will not have to face charges for unfair labor practices and the Gallo election result will remain undecided. It is clear that the boycott will be more important than ever.

SAN JOSE, Calif. (UPI) — A Salinas grower has testified that he and admitted political burglar Jerome Ducote twice met with representatives of the Central Intelligence Agency.

Stephen D'Arrigo was a witness Friday at the preliminary hearing before Municipal Judge John Schatz for Ducote, 46. Former Santa Clara County Sheriff's detective charged with more than 20 counts of grand theft and receiving stolen property.

Ducote, the father of eight, previously told a state Justice Department investigator that he conducted political burglaries in the 1960s in an effort to disgredit left-wing organizations amounted D'Arrigo backed Ducote's claims

he paid for some of his work. He also told the court that he met with CIA representatives in Washington, D.C., and San Jose in 1968 or 1968.

D'Arrigo did not say what took place at the meetings nor did he identify the federal agents.

He said he paid money to Ducote who had been active in the local Young Republicans organization, for conducting investigations in the late 1960s and he also paid Ducote's expenses when they went to Washington.

But, D'Arrigo told Schatz, they had a falling-out after Ducote began "using my name fraudulenty" to solicit funds from others for his burglaries.

Five other witnesses testified Friday that they loaned Ducote from \$1,000 to \$1,700. Four said the expeace officer agreed (spay them back with 50 pay cent interest within several days.

Schatz warned the witnesses that admitting they had been offered the high interest sould bring accusations of violating California's anti-loan shark laws. But they said they desired to centiane glong testimony.

SAN JOSE -Cesar Chavez has asked Gov. Edmund G. Brown Jr. to appoint an independent committee to investigate agribusiness involvement in political sabotage against the United Farm Workers Union. The telegram was made public during a press conference which followed Chavez's testimony yesterday at a preliminary hearing for Jerome J. Ducote. A former Santa Clara County sheriff's deputy, Ducote has said he was involved in burglaries against UFW which were financed by growers and with indication of coverup of the crimes by Delane and San Jose police. "Political agencies at all levels of government have been implicated," Chavez said in a telegram which listed the two polic départments, FBI, CIA, former State Sen. Hugh Burns and the Reagan Administration. He asked for investigation by a committee chaired by the governor himself or by Li. Gov. Mervyn Dymally.

Protesters EDU-T Picket

About two dozen demonstrators marched in WEDU-TV's parking lot yesterday protesting the station's decision not to show a documentary on Florida farm workers.

Led by Bob Weisberg, state boycot director for the United Farm Workers Union, the protesters included students, clergy and a retired school teacher. The demonstrators charged the station with censorship.

The documentary was to have been aired Monday night, but was cancelled.

Although the 90-minute program had been shown on a number of Florida stations. WEDU president and general manager Leroy Lastinger decided not to air the show when it was offered on the Public Broadcasting Service hookup
IN A PREPARED statement. Lastings.

IN A PREPARED statement, Lastinger said "it would not be in the public interest to broadcast this program.

His decision to pull the documentary out of the station's already published evening lineup apparently was made at the last minute.

In his statement, Lastinger said one important consideration in his decision was that the program "might tend to create divisiveness between certain socio-economic groups and could cancel out some of the gains that have been made in alleviating certain socio-economic problems."

Saying that WEDU was obligated to program in the public interest, Lastunger's statement said those interests could vary depending on the "particular geographic area" involved.

THE STATEMENT charged that the ogram, "Day Without Sunshine, treats the subject matter frought in this orgraphic area, with a high degree of notionalism."

The program, narrated by actor lames Earl Jones, was produced as a year-long specual project by WBPT-TV, a Miami PBS station, in 1973.

Lastinger met with a small group of the protestors in the station lobby, while the others were demonstrating outside.

The grey-haired Lastinger heard charges that his decision robbed farm workers of "freedom of the media."

WHILE FENDING off requests that he discuss his reasoning in making the decision not to air the show. Lastinger steadfastly claimed his motive was based on "concern for the people of our broadcast area."

"I'm sorry, the decision to run or not run a program is mine alone," Lastinger said.

He denied, in response to a protestor's question, that "any pressure" had been brought to bear to kill the show, which spotlights conditions among citrus crop workers in particular.

Lastinger also said he was a "lifelong Floridian," but owned no farm or citrus properties.

MRS. RUTH UPHAUS, a former St. Petersburg school teacher, said she had been "shocked and devestated by this decision", and wondered "what we're celebrating in 1976 if we haven't freedom of the media.

She said the public was already aware of the problems of Florida farm workers from previous recent discipares. "We still have slave labor in Florida and terrible conditions in some camps," she said.

But when Rev. Fred Eyster of the Florida Christian Migrant Ministry, demanded a more detailed explanation from Lastinger, the station manage asked the group to leave the office.




